The 1975 curriculum was even longer, 9 years ... The principle of CBSA was present when this curriculum was enacted. After 10 years of age this curriculum was replaced by the 1994 curriculum which was based on process skills. When the era of reformation rolled around, who knows how many times there were 'improvements' to the curriculum. There was the KBK curriculum (competency-based curriculum), the 2006 curriculum or also called the KTSP curriculum (education unit level curriculum). After that, the 2013 curriculum was born where the implementation is still not comprehensive at this time. Children are required to be more proactive in learning and finding learning resources. If you have children who are in elementary school to high school / equivalent who use the 2013 Curriculum, surely their bags are full of learning resource books and homework.

## 3) Teachers

Before this, teachers were completely free in the implementation of teaching and learning tasks. With students, teachers could take firm but educational action. In addition, teachers are also highly respected and honored. However, teacher welfare is still inadequate, so it is not surprising that many teachers are forced to look for additional income outside or side jobs. What is often a complaint about teachers that is often heard by the public is teacher welfare. The demands of the times are still not in accordance with the professional abilities of teachers. Law No. 14 of 2005, which discusses the Certification of Lecturers and Teachers, emphasizes professionalism and the mission of teacher welfare. If teachers complain about welfare issues, then professional skills are the demands of the government. Teachers have their professional abilities relied on, therefore teachers must be prosperous physically and mentally so that the certification program can be carried out effectively starting in 2007. the teacher certification program to date has been running for 9 years. Almost the same age as the curriculum before the reform era. It can be assessed whether this program has not been successful or has been successfully carried out. It is very different from the current situation which is fully facilitated and very easy to access lessons via the internet. But it is unfortunate because in ancient times there were not many ways to access and obtain information sources for learning like today. Because in ancient times to find additional references to increase knowledge and knowledge was very difficult because in the past the sources were only newspapers and books. It is very much different from today's times which are already very numerous and extensive to get learning resources from various media. Not only in books, learning can now be obtained through reading articles on the internet, or through various seminars and can also be through video shows. Therefore, the teacher is no longer a teacher but rather a facilitator or director to motivate students to find their own sources of information.

Learning tools in education in ancient times and now are also very much different. In the past, they still used simple and makeshift learning tools, one of which was using chalk, wooden rulers and black boards. In addition, only notebooks were used for lesson notes. Unlike today, it has now become more sophisticated including using white boards and markers. Along with the development of LCD Projector technology as a tool for the learning process in class, there are even students who are asked to bring laptops to further facilitate the teaching and learning process.

The author's analysis is in accordance with what has been described above that over time there will be many changes that occur both in education and situations due to the changing times that are increasingly developing. The findings of the research that has been carried out are very many differences between the past and present both in the

situation and the teaching and learning process. Learning aids were only makeshift.

Whereas nowadays, it is all sophisticated, we can access anything through cellphones. Learning tools are also increasingly sophisticated, school can also be done via cellphones, which is the main factor that makes children lazy to read books they are just cool playing games on cellphones. So parents need to provide more supervision to their children to be able to limit their gadgets and prioritize education so that children are not dependent on cellphones
